
## Investment Objective

## Fund Manager's Comment

In March 2025, the MSCI Asia Pacific Islamic ex Japan Index (MIAPJ) increased by 5.16% driven by lower 10-year US Treasury rate that fell from 4.2% to 4.0% during the month. India became the best performer within the region supported by stronger Indian Rupee which appreciated by 2.3%. In terms of sectors, Energy and Materials were the best performers due to the lower DXY index that fell by 4.0%. On the other hand, Taiwan became the worst performer because of trade war escalation between US and China.


