FUND MANAGER'S COMMENTS

Equity

Weak selection in information technology, communication services and consumer staples was partially offset by selection in materials, energy and health care. On a regional basis, weak stock selection in Japan and North America was partially offset by selection in United Kingdom. Within health care and materials, our top relative contributors were overweight to Haleon and Barrick Gold, respectively. Within information technology and consumer staples, our top relative detractors were overweight to Synopsys and e.l.f. Beauty, respectively. Shares of Haelon rose following the company reporting fourth-guarter 2024 earnings that showed full-year adjusted EPS and revenue beat consensus while also announcing \$500M of share buybacks in 2025. Management provided 2025 full-year outlook along with medium term guidance that expects mid-single digit organic revenue growth. Shares of Synopsys, a US-based electronic design automation company, fell during the period despite the company releasing earnings in-line with expectations and reiterating guidance. Tariffs and economic instability between the US and China continue to effect Synopsys and its competitors. The company's acquisition of Ansys is still ongoing, with final steps and closure aimed for the middle of 2025.



FUND MANAGER'S COMMENT (CONT')

Sukuk

The sukuk sleeve underperformed its benchmark by 36bps (Sukuk recorded a positive return of 0.76% vs benchmark of 1.12%), government agency contributed positively to the portfolio while government national were the detractors. KSA Sukuk Ltd was the main contributor while Republic of Indonesia Sukuk was the main detractor. The funds duration (2.95) is shorter than the benchmark (4.35). The fund duration is 7.3 years.

Reclassification of Shariah non- compliant status Risk	This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), the Shariah adviser or the Shariah boards of the relevant Islamic indices. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event the Shariah non-compliant securities are disposed at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund to fall.			
Credit and Default Risk	Credit risk relates to the creditworthiness of the issuers of Sukuk, Islamic money market instruments and/or financial institutions where the Islamic deposits are placed and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuer of the Sukuk, Islamic money market instruments and /or financial institutions where the Islamic deposits are placed may impact the value as well as liquidity of the Sukuk, Islamic money market instruments and/or Islamic deposits. In the case of rated Sukuk, Islamic money market instruments and financial institutions, this may lead to a credit downgrade. Default risk relates to the risk that an issuer of a Sukuk, Islamic money market instrument or a financial institution where the Islamic deposits are placed either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the Sukuk, Islamic money market instruments and Islamic deposits. This could adversely affect the NAV of the target fund.

Interest Rate Risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and/or Islamic money market instruments. When interest rates rise, Sukuk and/or Islamic money market instruments prices generally decline and this may lower the market value of the target fund's investment in Sukuk and/or Islamic money market instruments. The reverse may apply when interest rates fall. Meanwhile, Sukuk and/or Islamic money market instruments with longer maturities and lower profit rates are more sensitive to interest rate changes.		
Equity Risk	As the target fund will be investing in Shariah-compliant equities, the target fund will be affected by equity risk. Generally, equity risk may arise in the following forms, i.e., equity risks related to external factors and equity risks related to company-specific factors. All of these related equity risks can adversely affect the prices of equities, which would negatively impact the performance of the target fund.		
Country Risk	The target fund is also subject to country risk. The value of the assets of the target fund may also be affected by the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund may invest in. Further, when investing in foreign markets, there are countries which may require prior approvals before investments can take place.
